## 2008 GATE CITY BAR ASSOCIATION HALL OF FAME Nomination Packet

### Instructions and Guidelines

#### A. Nomination Requirements:

- Nominee must have been licensed to practice law for at least 10 years.
- Nominee must be a member of the legal profession, in good standing.
- Nominee may be active or retired
- If selected, nominee must be able to attend induction activities in Atlanta, Georgia(unless awarded posthumously).

B. All nominations must be submitted on the official nomination form included within this packet.

Your nomination packet must be postmarked on or before **Friday, August 1, 2008.**

Nominators *must be* current financial members of Gate City Bar Association.

Nominators will receive confirmation when completed nomination forms have been received.

C. The person making the nomination should work closely with the nominee to ensure that all required materials are included in the packet. Self-nominations are accepted.
